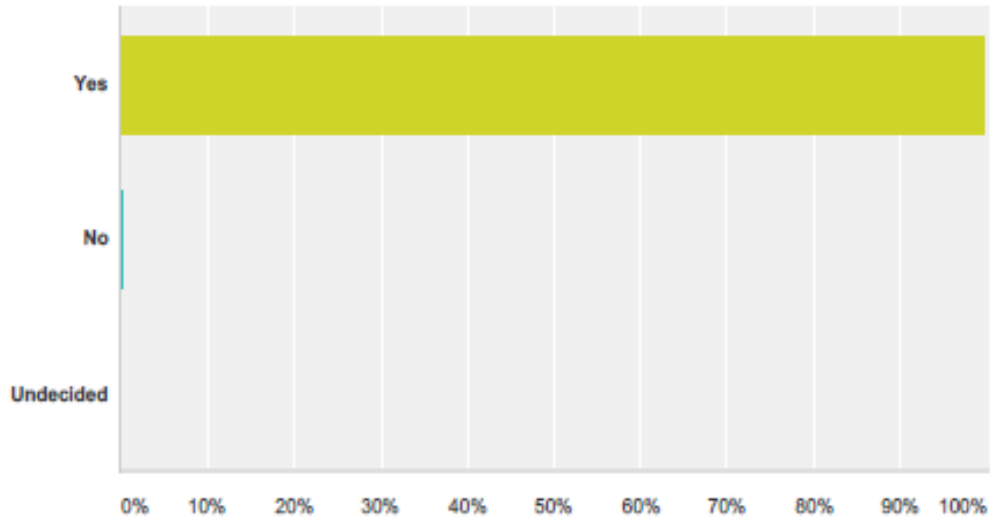


Q1 Should Dr Philip Nitschke be able to conduct Exit Workshops for Exit Members?

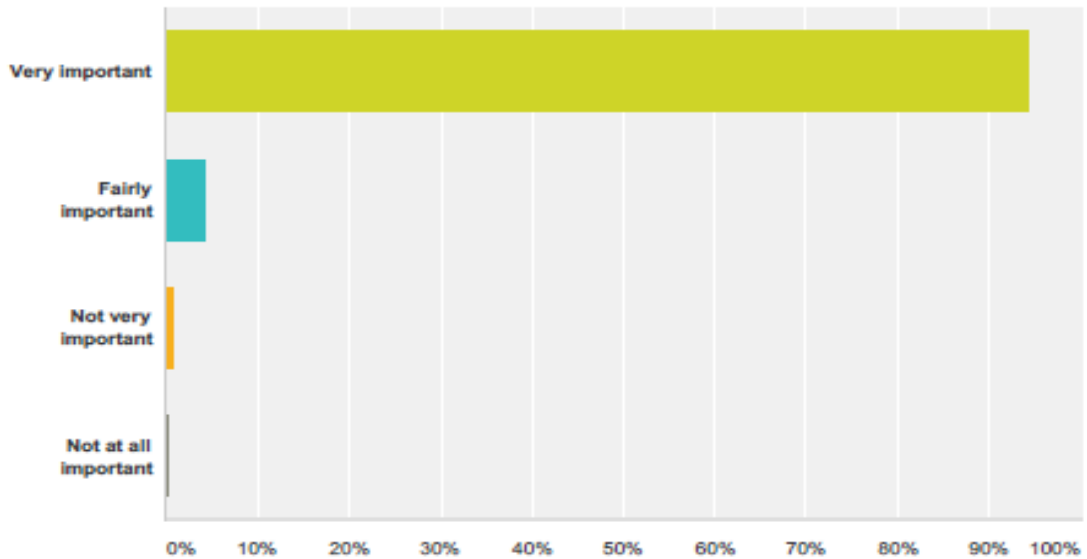

Q8 How important is it for Dr Nitschke to continue to publish information about end of life choices in the Peaceful Pill Handbook & eHandbook?

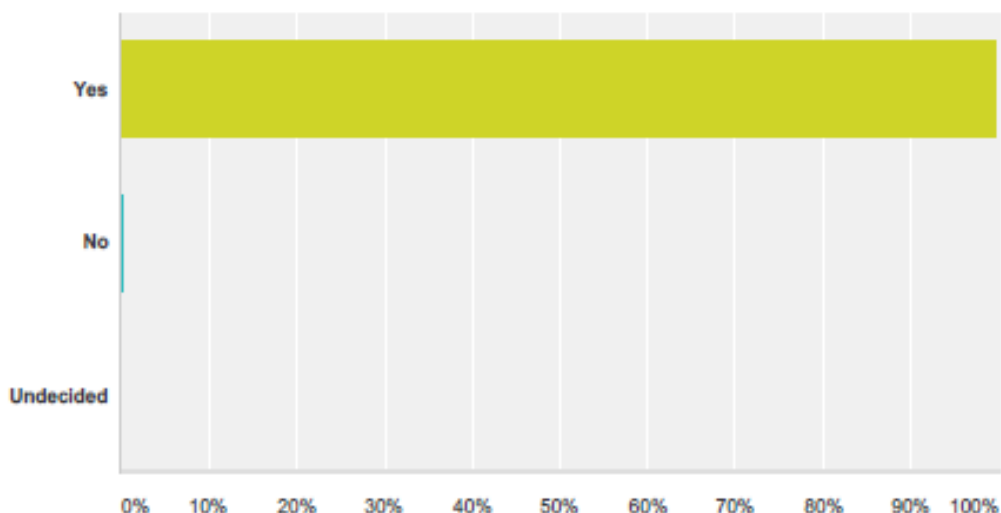

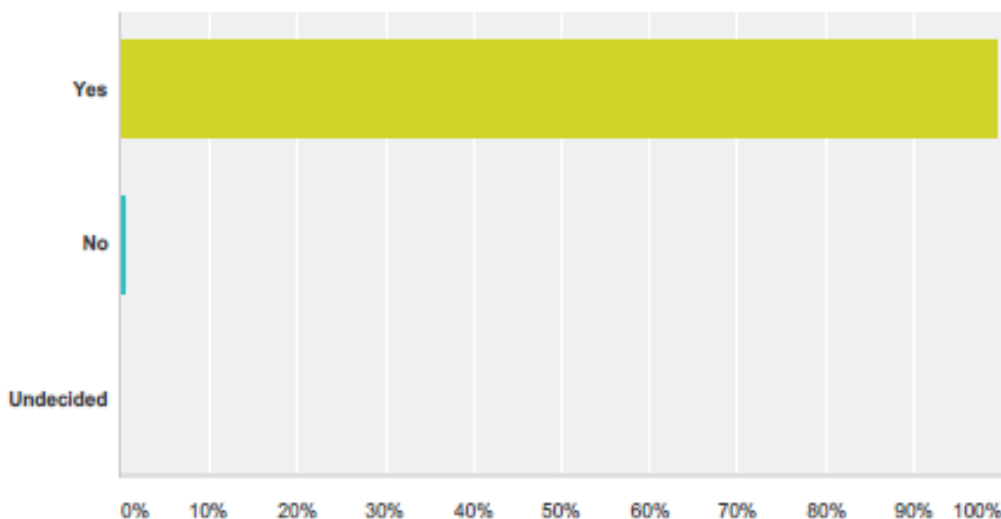

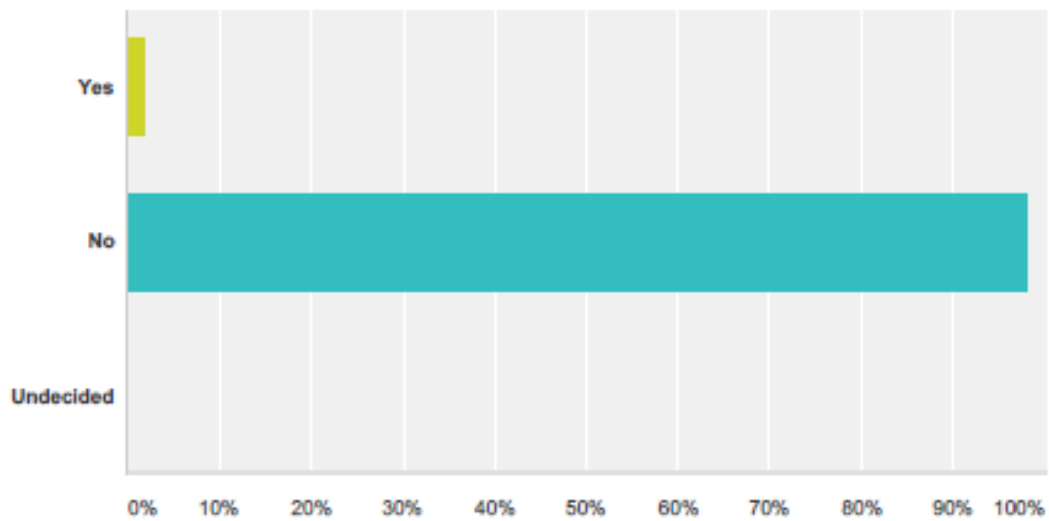

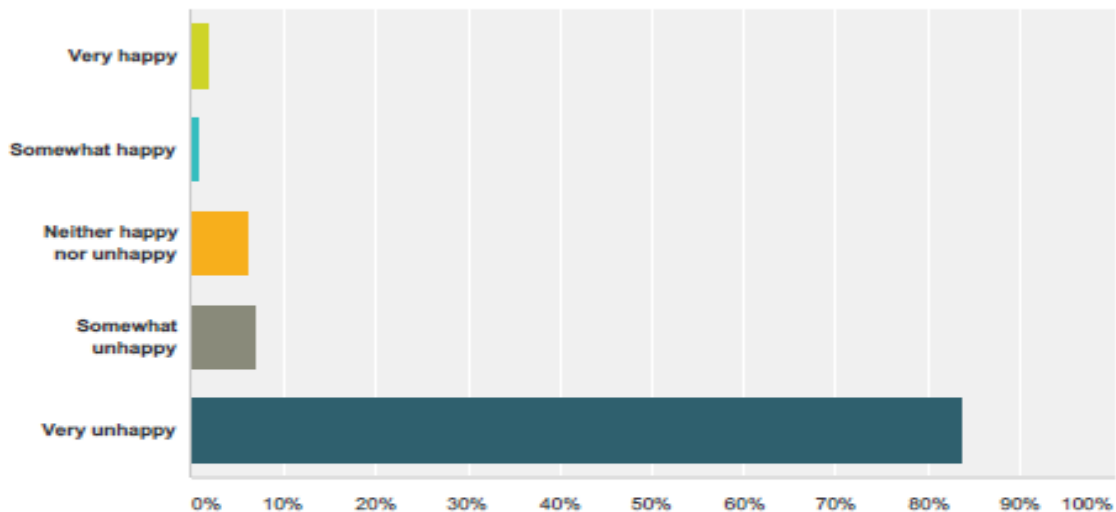

Q6 How happy would you feel about Dr Nitschke referring you to a mental health service because you asked him a question about Voluntary Euthanasia?

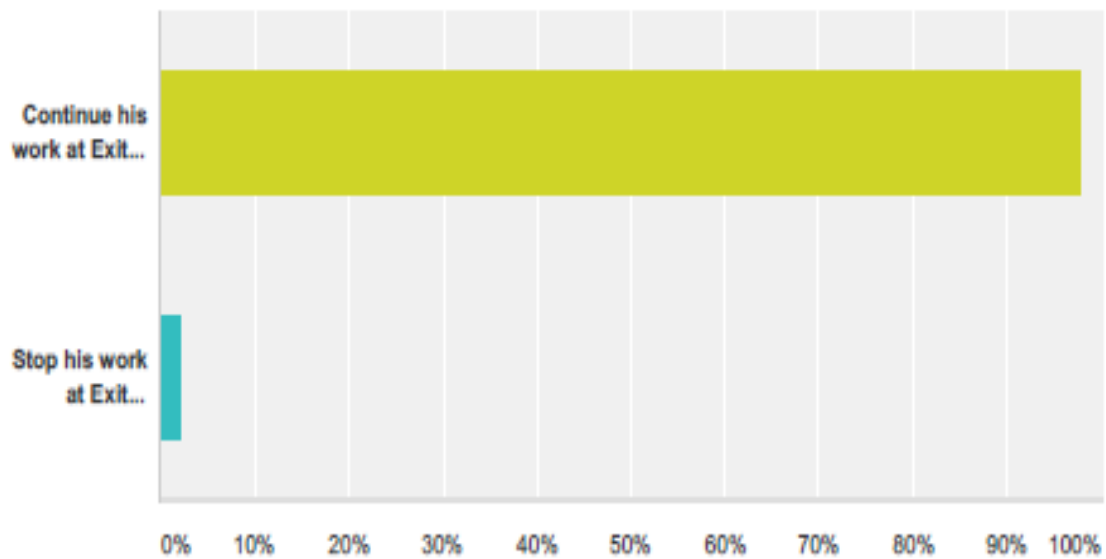
