New Prime Minister Dumps Mandatory Net Filter!

Our so-called 'moral issue' has never found a natural home in either the right or the left of the political spectrum. In days gone by, strong support has come from right wing politicians such as One Nation's Pauline Hansen and the Country Liberal Party's Marshall Perron, to those of the mainstream left, such as Australian Greens' leader, Senator Bob Brown

Perhaps the only characteristic which can be noted as having an impact upon a politician's disposition towards Voluntary Euthanasia is religiosity. In this regard, the more faith-driven a politician, the less likely he or she is to support a person's right to choose. And not only for VE, also for abortion.

This is perhaps why Exit became a little hopeful that the proposed mandatory Filter would join the list of policies relegated to the political back bench upon this change of Prime Ministers.



After all, Australia's 27th Prime Minister, Julia Gillard, had just taken the Prime Ministerial affirmation (over the oath) at Government House. Later the same week the Prime Minister publicly declared herself

an atheist on Melbourne *ABC* radio. The Exit community was, rightly, becoming excited at the winds of change blowing through.

When *The Age* newspaper ran an online poll asking readers if Gillard's atheism was likely to make her

more open-minded, the answer came back a resounding 'yes' (64%). At least that was until the poll became stacked by professional Christian lobbyists (see eg. Catch the Fire Ministries) whose efforts led to an eventual split result of 50:50.

For better or worse, the current Government is now set to go to the Federal election standing for quite different things to its

While it is still early days, it now appears that the Clean Feed plan will be sent off to the joint States

and Territories inquiry for a 12 month review. The review process will focus on the entire RC (refused classification) protocol. From Exit's point of view we hope that the lack of an independent umpire in this country's censorship regime will be centre stage.

To this end, Exit will now write to Communications Minister, Stephen Conroy, requesting membership of the planned stakeholder reference group. As the author of one of only three books (the other two advocate jihad) to be banned in Australia since 1973, Dr Nitschke is well-placed to contribute to improving Australia's current broken system.

internet filter discussions, freedom of speech and access to information is an age old issue.

The current exhibition that Art in the Library has been involved with, is titled Banned Books in Australia. It covers the three hot topics of **Obscenity**,

Blasphemy and **Sedition**. We collected books from within our own library, personal copies of titles, as well as artwork inspired by the topic.

The two main drivers for this exhibition are the Bibliographical Society of Australia and New Zealand's Annual conference (2010) titled:

To Deprave and Corrupt: Forbidden, Hidden and Censored Texts.

The second driver has been around a little longer. Back in 2006 our library was forced to remove books from our shelves and lock them in a cupboard, where they could no longer be accessed.

Not even for the academic context within which they were bought!

You can thank the then Attorney-General Phillip Ruddock for this. And as we sit here four years later, they are still deemed too dangerous for public consumption (even though you can access the texts over the internet).

Monoxide Revisited Dignity on the Move

An increasing number of requests for information on the use of carbon monoxide gas (CO) has prompted a review of the topic for inclusion in the August update to *The Peaceful Pill eHandbook*.

Much of this interest has been prompted by media reports of the use of charcoal burners to produce the gas in confined spaces. Jack Kevorkian's story and his use of the gas also renewed interest.

In the experiments carried out by Exit several sources of the gas were investigated and the concentrations that were produced in several closed environments measured. The goal was to produce concentrations of the gas that would exceed 10,000 ppm (1%). Environments where CO levels of greater than 1% occur unconsciousness results with 2 - 3 breaths and death in less than 3 minutes.




Generation Methods

Exit looked at the traditional exhaust gas as a source, charcoal 'BBQ' burners (pictured), and a variety of chemical generation methods including the catalytic breakdown of formic and oxalic acid and the reduction of sodium

carbonate with zinc. The original 'COGen' machine (pictured) developed by Exit was modified to trial the chemical generation of the gas.

Measuring CO Concentration

Two detectors were used. A hand held model (pictured - with 20c coin) uses hand aspiration for the gas with a modified probe that enables x10 multiplication of the range of concentrations read - giving measurable levels of up to 2%.


Containment

A motor vehicle provides the most convenient closed environment and offers the opportunity of a secluded bush setting. To reproduce the effects in small closed room a standard 20ft shipping container was used.

Levels of CO Produced

Lethal monoxide gas concentrations were produced various setting using different generation means. Both charcoal burners and chemical generators were found to be effective. The highest concentrations produced, >25,000 ppm in a vehicle, took just over 10 mins to reach from the time the COGen was activated (see graph). Using this set up death would have occurred within the first five minutes. Charcoal burners were found to be significantly slower.



Exitorial

Well, what a difference a Prime Minister makes! One day, those of us in Australia are told to expect Internet Censorship before our forthcoming national election on 21 August.

The next day we find the ridiculous Clean Feed proposal relegated to the political back benches along with former PM, Kevin Rudd.

Whether the Bill stays away from the Parliament only time will tell. The pundits seem divided on whether the Clean Feed will prove terminator-like and be revived post-election or whether it will disappear into Australia's political history, remembered as an abberation of an overly-religious PM and front bench. And perhaps that is the point.

Australia now has an atheist as its leader. Not since the dizzy days of Bob Hawke in the 1980s and early 90s has the country had a leader for whom the church is of so little relevance.

Already when I speak with Exit members at our Webinars I am being asked if Julia Gillard will make a difference on the Voluntary Euthanasia issue. While I'd like to think that she will, she probably won't. Why not I am asked?

All signs to date point to the fact that this is a canny politician who is not about to nail her colours to the mast when it comes to VE, or even to the rights of the Northern Territory to make its own laws on the issue of end of life choices.

As Australian journalist, Patricia Karvelas, astutely noted during the recent ABC TV's Australian Story episode (which aired at the beginning of the week in which Gillard became PM), Julia Gillard is "not afraid of dropping a principle to get to where she wants to get to".

That said, Gillard's appointment to head the Parliamentary Labor Party does buy Exit time. And, perhaps most importantly, it stops our Prime Minister acting as the mouthpiece for Australia's hitherto powerful Christian lobby groups.

While Exit has always welcomed members of all faiths, as well as no faith at all, 'the Church' has continued as our staunchet political foe. The Rights of the Terminally III Act was overturned by forces underwritten by the Church. My Peaceful Pill Handbook was banned by similar means. If nothing else is achieved by Gillard government, I would hope that Church interference in politics ceases.


I hope that Australia becomes a place where censorship is a thing of the past, where ideas on pressing social issues (such as VE) are given the public space they deserve to be discussed maturely, and with both economics and libertarian notions such as choice, dignity and independence in mind.

Following the death of Western Australian couple Jennifer (61) and John Stewart (66), Exit will cooperate fully with WA authorities as they prepare their report for the Coroner. The couple contact-

ed Exit several years ago to purchase the Peaceful Pill Handbook. While lennifer was terminally ill with breast cancer, John was not.

Known as a devoted couple, neighbours told the media that he would not have wanted to live without her. The couple's daughter, Suzanne Tugwell said much the same "he adored us but he just loved her more than life itself."

Mary was a long time member of Exit and she was one of our staunchest and most vocal public defenders, particularly where critics within the voluntary euthanasia movement were concerned.

On her website www.yourchoiceindying.com Mary wrote:

"The work that Exit International undertakes is both thankless and hard, but in the face of ongoing needs of an ageing society absolutely essential to our wellbeing for having control over our end of life decisions.

Mary began her support of 'choice in dying' after surviving an ovarian cancer scare. In remission since July 1999, Mary's website was born in 2004 and soon became her life's work.

In 2006, Mary featured in a little-known documentary screened on SBS TV. The film followed a trip she took to Mexico in search of liquid, veterinary Nembutal.

Unfortunately this was in the days prior to the publication of The Peaceful Pill Handbook. Mary had little knowledge of how to purchase Anastesal (the most common Spanish name

Nembutal) for and the film captured her failure to come home with her 'peaceful pill'.

passionate advocate of all things VE, not to mention her DNR tattoo on her chest, Mary wanted a lively public debate.
