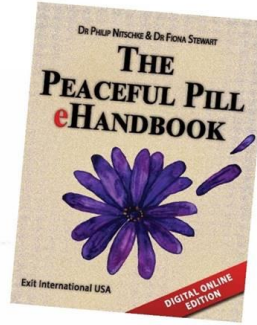

• Oz Border Force Seize Handbook (again) •

Exit has recently had reports from four elderly people in Australia that their ordered copies of the 2017 edition of **The Peaceful Pill Handbook has been seized by Australian Customs.**

Border Force cite **Customs Regulations from 1956** (err that is 61 years ago) to justify the censorship of the book in this country.

Instead of receiving their much-anticipated book, these people have received a notice from Australian Border Force saying they are **not allowed to have their book** because books:

'that offend against the standards of morality, decency & propriety generally accepted by reasonable adults' are prohibited in Australia.

There is no mention of who, why or how nameless, faceless agents are empowered to decide what adult Australians may or may not read in the privacy of their own homes.

To remind readers, when the **Peaceful Pill Handbook** was first published by Exit in 2006, the book received an **18+ classification**. This meant that it had to be sold in **brown paper & kept under the counter at book stores** (rather than on public display). Regulations commonly given to hard core porn.

Within a month of the Office of Film & Literature Classification rating the book 18+, then **Attorney General Philip Ruddock*** & **Right to Life NSW** jointly appealed the decision to the **Literature Review Board**.

The Board overturned the classification of the book and the 2006 Australian published edition of the book was then **banned outright** and given an **RC (refused classification) rating**.

Since this time the book has been **published freely in the US and the Netherlands**; two countries that don't ban books and which value the democratic principles of **free speech**.

At the time of press, at least one Exit member has applied to have the book released to him. We will keep readers posted of what happens next.

Congratulations to everyone who donated to the crowd-funding campaign on [GoFundMe.com](https://www.gofundme.com) to help Exit's Wellington Chapter Coordinator Suzy Austen with her legal expenses.

As we have previously reported, Suzy Austen has been charged with assisting the suicide of fellow Exit Member Annemarie Treadwell. Annemarie died in June 2016 after taking her Nembutal.

To date Suzy has hired high profile New Zealand Barrister, Dr Donald Stevens QC.

We expect that the money raised will help Suzy mount a vigorous defence in court and beyond.

Exit is proud of Suzy and pleased to be able to support her in this way. We see her forthcoming trial as a test case destined to put the issue of a person's right to die at the front of public discussion in New Zealand.

Exit Director Dr Philip Nitschke plans to be in Wellington for the trial later in 2017.

• **Facts behind Clive Deverall's Death** • **'The Australian' omits Important Stuff**

Dr Clive Deverall's death was recently reported in *The Australian*. The article by Victoria Laurie has omitted a number of relevant facts about Clive's death. (Laurie is well known to Exit due to her misleading coverage of Erin Berg's death in Tijuana back in 2008.)

Clive was not only the long-time President of the West Australian Cancer Council (and a former President of Palliative Care), he was also a member of Exit International.

As it happened, Clive Deverall last phoned Exit on 20 September last year. He was in a panic. He had been contacted by Australian Border Force. They were over to his house as he spoke, to search for drugs.

Clive Deverall had joined Exit in early 2016 so that he could get control over his dying, just like he had had over his living.

The only problem was that the Australian Feds knew about Clive. And they sure as hell didn't want him to *have Nembutal, let alone take it.*

Clive had been concerned about testing the purity of Nembutal sourced on the internet. These days professional lab testing is easy. You send 0.05gm (read a miniscule amount) of your powder to Barcelona, pay €70 by Bitcoins and the report is returned to you by email 10 days later (*See Chapter 18 of the online Peaceful Pill eHandbook for further details*).
Too easy!

The end result was that Clive, a dying person, was again the victim of harassment by the authorities of Australia.

If there is any reason why Clive Deverall went off into the bush and shot himself, it is surely because of his harassment by the authorities.

It is in Clive's name, and others like him, that Exit will continue to call for the decriminalization of the importation / possession of Nembutal for personal use (should the need ever arise).

A peaceful death is everybody's right!
